Statement Condemning the Destruction of the National Stadium and the Woods of Jingu Gaien, the Outer Garden of the Meiji Jingu Shrine by The Custodians of the National Stadium, Tokyo March 5, 2015

The Custodians of the National Stadium, Tokyo, strongly condemn the Japan Sport Council (JSC) for embarking on the demolition of Tokyo's iconic National Stadium, venue of the 1964 Tokyo Olympics. As a preliminary measure, JSC workers have felled Jingu Gaien's historic trees, which have been cherished by athletes and citizens alike. The JSC is taking these ill-advised steps to begin the construction of a colossal new main stadium for the 2020 Tokyo Olympic and Paralympic Games. The construction costs are already estimated to double and even triple the initial estimate. Similarly, management and maintenance costs will spiral out of control. Thus, the new stadium is destined to become a white elephant after the Games.

Beginning in November 2013, we organized a series of symposia to discuss the multifaceted aspects of the project. Prominent architects, urban planners, historians, environmentalists, economists and facilities managers have unanimously pointed to the absurdity of JSC's plan. Exploring the many problems in detail, these experts warned that the impractical proposed monster stadium will prove an environmental, financial, and aesthetic burden not only to Tokyo, but to the whole nation. We made public every bit of the amassed knowledge and information and submitted the findings to the JSC and relevant authorities. We have also submitted petitions asking them to consider realistic, feasible proposals to retrofit the 1964 stadium. Unfortunately it appears our appeals have never been considered.

Therefore, we direct our condemnation to both the Japan Sport Council and all the recipients of our petitions. The members of the group (listed below) have ignored our appeals both in writing and in person:

Those listed are in positions to be fully informed of the serious problems inherent to the new national stadium project. However, they have failed to consider making any fundamental changes. When the results of their failure become evident, they should take legal and ethical responsibility, that is, when the inevitable difficulties of constructing the new stadium and of managing the unwieldy monster hit home and its finances become even more costly.

We also believe the Council of Advisors for the National Stadium Future Plan, who approved the terms of the 2012 International Design Competition for the New National Stadium, must share the responsibility for a facility that will become a national burden. Among the Council members listed in the Attachment hereto, we single out Shunichi Tokura and Tadao Ando. Tokura has insisted on the retractable, and perhaps dangerous, roof as a must for commercial music events. Ando chaired the Design Competition, which awarded first prize to Zaha Hadid, whose designs fail to consider both technical and financial feasibility.

In making this statement, the Custodians of the National Stadium, Tokyo, represent 36,000 people who have supported our petitions, the panels of top-level speakers of our symposia, public opinion in Japanese and international media reports and surveys, including, among others, the 62,751 naysayers to any new national stadium in the YAHOO January 2015 voting.

The Custodians of the National Stadium, Tokyo, grasp that the Tokyo Olympic national stadium issue is much more than a controversy about a construction project. We are fighting against an unprecedented threat to Tokyo's landscape. We are fighting for Tokyo's urban living environment and for cultural and historic assets that all citizens can enjoy now and in the future. The Japan Sport Council's steamrolling tactics violate every aspect of the rules of a democracy. In good conscience and with sound judgment, we shall never stop raising our voices against the planned stadium and the destruction it will cause.
